Kasane – Botswana Development Corporation (BDC) continues to explore opportunities to invest in viable commercial ventures, and facilitate the local ownership in key sectors, whilst in turn stimulating private-sector growth. To this end, the Corporation is pleased to announce the successful transfer of its 40% shareholding and facility interest in Kwalape Tours and Safaris (Pty) Ltd, to a citizen-owned company, Dekete Guys (Pty) Ltd ("Dekete"). The transaction was concluded at a hand-over ceremony on 13 August 2018 at Kwalape Safari Lodge in Kasane. The transfer is part of a broader strategy by BDC to divest from mature industries as well as those sectors that had demonstrated adequate private sector capacity to invest and operate in those sectors. Kwalape Tours and Safaris is one such entity.

The Corporation has approved an offer for its interest in Kwalape, being the purchasing of both ordinary and preference shareholding and credit facilities. The transfer to Batswana owners offers the company the opportunity to accelerate its development plans which will include the enhancement of its luxury hospitality offering and expanding the business' footprint.

"We are pleased to see Kwalape having attained a mature business status as evidenced by its ability to selfsustain in a tough and competitive tourism sector. On the back of our robust corporate governance processes, we ensured all checks-and-balances were followed whilst reviewing prospective investors in order to appoint the right operation to take-up our shareholding. We believe the profile and projections of this investor would sustain business continuity and open new doors for Kwalape's growth in the long term. We are confident in Dekete's vision for the business," said BDC Managing Director, Mr. Bashi Gaetsaloe.
